ABSENCES: KidUnity is a non-profit program with fixed expenses. Therefore we cannot give credit or makeup days for the absence of your child. No refund shall be provided for non-attendance, late arrival, early departure, or dismissal for cause.

TARDINESS & PICK UP: Parents are expected to drop off and pick up their children promptly from the activity site each week. Locations and directions to each week's activities will be provided in advance and on KidUnity's website. No refund shall be provided for late arrival or early departure.

PHOTOGRAPHY & VIDEO CONSENT: Occasionally, KidUnity will us	e a participant's photograph and/or
film/video for promotional purposes of the organization. In addition, students	s may have their work published in
local and national media. Please consent to this policy by checking this box	and initialing next to it.

CONFIDENTIALITY: KidUnity is committed to keeping personal family information confidential. We will only release information to parents/guardians.

CONDUCT: KidUnity's programs are designed for students who have the interest and maturity to work with peers and civic leaders to address complex community problems. Students who are unable to work cooperatively and confront challenging social issues with maturity may be asked to remove themselves from the group. No refund shall be provided for dismissal for cause.

RELEASE OF LIABILITY: I hereby agree to hold harmless KidUnity, KidUnity staff, Directors, administrators and Members of the Board of Directors from any liability related to any and all KidUnity activities and programs.
