TARDINESS & PICK UP: Parents are expected to drop off and pick up their children promptly from the activity site each week. Locations and directions to each week's activities will be provided in advance and on KidUnity's website. No refund shall be provided for late arrival or early departure.

PHOTOGRAPHY & VIDEO CONSENT: Occasionally, KidUnity will use a participant's photograph and/or film/video for promotional purposes of the organization. If you do **NOT** want KidUnity to use your child's photograph and/or film/video for promotional purposes of the organization, please check this box and initial next to it.

CONFIDENTIALITY: KidUnity is committed to keeping personal family information confidential. We will only release information to parents/guardians.

CONDUCT: KidUnity's programs are designed for incoming fifth graders who have the interest and maturity to work with peers and civic leaders to address complex community problems. No refund shall be provided for dismissal for cause.
